The Free Speech Center, a nonpartisan, nonprofit public-policy center at MTSU, works to build understanding of the First Amendment and Bill of Rights through education, information, and engagement.

The center's mission is to give young people in particular the information and insights they need to be better and more aware citizens. Doing so has placed MTSU at the nation's forefront when it comes to exploring the role of the First Amendment in our free society.

BY THE BOOK

The launch of the First Amendment Press—the first academic press in MTSU's history—led to the publication of insightful new books about First Amendment freedoms. The press also revives important First Amendment books that have gone out of print.

Authors to date include MTSU Honors Dean John Vile, who is an internationally recognized First Amendment expert, and Belmont law professor David Hudson, whose book *The Bill of Rights: The First Ten Amendments* provides a succinct and incisive overview of how this central document in American history protects our basic freedoms.

The First Amendment Press also publishes books, teacher's guides, and white papers on the Bill of Rights and free expression for teachers to use.

Lessons in Liberty, the center's newest initiative in First Amendment education, features an unprecedented aggregation of online teaching materials for all teachers from primary school through college.

One of the pillars of the Free Speech Center is its 1 for All campaign, which provides online materials, course content, and study guides for teachers who want better resources to teach about the First Amendment. This interactive, educational tool encourages students to submit photos, videos, songs, and stories that reflect the value of freedom in America.

The center's one-of-a-kind First Amendment Encyclopedia along with its news website that provides online daily news and insights into free expression—will draw more than 4 million visitors this year.


Since the encyclopedia was added to the website (a joint project of the center and its on-campus partner, MTSU's John Seigenthaler Chair of Excellence in First Amendment Studies), even more teachers and researchers have used and benefited from the site.

The amount of content also has been expanded. It includes essays and entries covering court decisions, doctrines, people, laws, events, issues, and organizations. The encyclopedia now averages 20,000 daily hits and has become hands-down the most comprehensive First Amendment resource available to the public.

The news website also offers a comprehensive repository of First Amendment history and law, and even features a journalist hotline, so reporters from across the country can call MTSU's specialists, seeking their views on First Amendment issues. There is really nothing else like it on the web.











THE POWER OF MUSIC


2022 saw the launch of the center's new Free Speech in Music award, and the inaugural awardee was Felix Cavaliere, a founding member of the legendary rock band The Rascals.

Presented by the center in partnership with the University's Center for Popular Music and College of Media and Entertainment, the honor recognizes artists who have used their talents, fame, and visibility to address important social issues and who have demonstrated the power of music as a form of free speech.

Cavaliere contributed much through his music and engagement with American society, from the anthemic 1968 hit "People Got to Be Free" to his early commitment to onstage diversity to years of supporting important causes. With The Rascals, he is a member of the Rock & Roll Hall of Fame and the Vocal Group Hall of Fame; he also was inducted into the Songwriters Hall of Fame and Musicians Hall of Fame. His career with The Rascals featured four No. 1 hits, including 1966's "Good Lovin'" and the aforementioned "People Got to Be Free." Both featured Cavaliere's distinctive lead vocals and Hammond B-3 organ. The band, which had 10 top 20 singles and six top 20 albums, also stood up for civil rights, refusing to perform on segregated tours and ensuring that at least half of the artists who performed with them were Black.
